REGULAR MEETING MINUTES

1. Mr. Bender led the Pledge of Allegiance.
2. The meeting was called to order at 6:01 pm.
3. Roll Call: Those present were Mrs. Quine, Mr. Fehl, Mr. Taylor, Mrs. Lindsay, Mr. Bender, Mr. Heuermann and Mr. Strausbaugh. Others in attendance were Ms. Baughman, Dr. Baele, Rachel Daymude, Andy Daymude, Rob Hanover, and Patrick Sheets.
4. Communications / Presentations – None at this meeting.
5. Presentation from Audience on Agenda Items - None
6. New Business – Board of Education Hearing
 - a. Mr. Bender led a Board of Education hearing that began at 6:02 p.m. to determine if Mrs. Rachel Daymude would be excluded for one calendar year from all school events and property as per Board Policy 8:30. Ms. Baughman, administration representative, presented the evidence and information from an incident that took place at Oak Grove School on October 24, 2019 to the Board of Education which prompted the hearing. Mrs. Daymude and her legal counsel, Rob Hanover, presented their case and regrets for her actions and requested exceptions to the recommended exclusion due to 8th grade events. The Board of Education asked clarifying questions of both sides and each side presented their closing comments with Ms. Baughman and Dr. Baele making the final statement and recommendation of total exclusion for one calendar year. The hearing ended at 6:54 p.m. The Board deliberated the merit of the request versus the support of the administration, as well as the impact on Mrs. Daymude's daughter. The Board also discussed the importance of the Oak Grove reputation and how the District looks to others when parents behave in such a manner.
 - b. Action by the Board of Education

ACTION: Mr. Bender made the motion to exclude Mrs. Rachel Daymude from all school events and District property for a period of one calendar year with the exception of 8th grade nights, awards nights, graduation, drop-off & pick-up, sign-in and sign-out, with all exceptions being requested by Mrs. Daymude in advance to and approved by the administration. It is agreed that allowance for the exceptions will be pending no initiating contact while at an event or on school property. In the event of a violation of the Board decision, Mrs. Daymude is barred from all school events and school property and waives all right to contest the allegations. The motion was seconded by Mr. Fehl and carried with all aye votes.
7. Old Business – Action Items


a. Administrative Procedure – Parental / Extracurricular Participation Contract

ACTION: Mr. Taylor made the motion, seconded by Mrs. Lindsay to approve and direct the administration to implement the administrative procedure for the parental / extracurricular participation contract for all such activities at Oak Grove School effective immediately. Motion passed with all aye votes.

8. Presentation from Board Members / Administration on Non-Agenda Business – None

9. Motion for Adjournment

ACTION: Mrs. Quine made the motion to adjourn at 8:03 pm, seconded by Mr. Strausbaugh. All were in favor and the meeting was adjourned.
